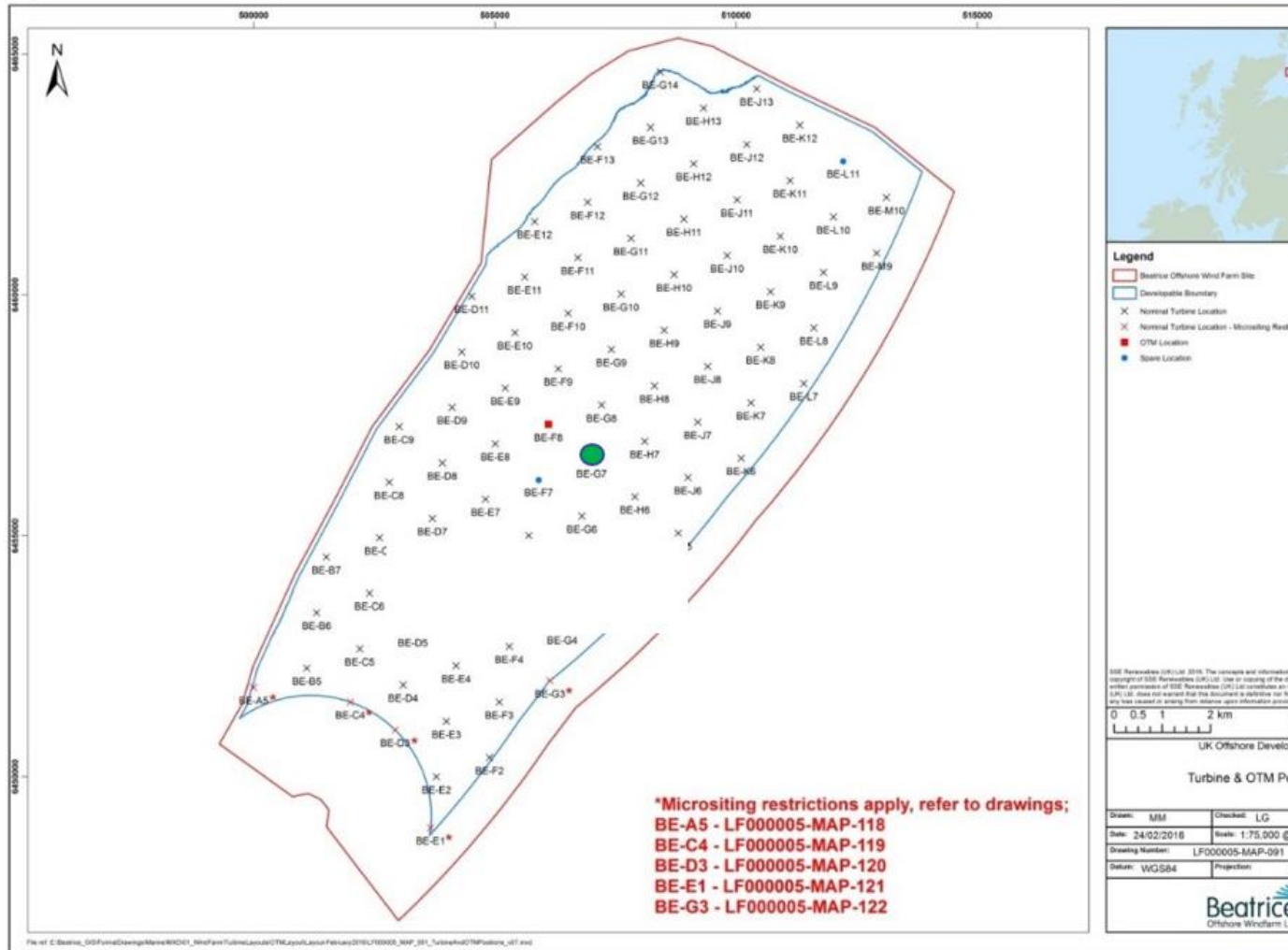


Figure 1. WTG locations for survey work – Green Mark

4. General Safety Advice

All vessels engaged in the construction activity will exhibit appropriate lights and shapes prescribed by the International Regulations for Preventing Collisions at Sea; relative to their operations. All vessels engaged in the activity will also transmit an Automatic Identification System (AIS) message.

Use of Safety Zones within the Beatrice Offshore Windfarm Area:

The Secretary of State for Business, Energy and Industrial Strategy (BEIS) has approved the use of safety zones under the Energy Act 2004 for the installation of wind turbines and offshore transformer module foundations/substructures within the Beatrice Offshore Windfarm. The approval was granted on the 17th March 2017.

The Secretary of State has declared Safety Zones under the following terms: During Operations and Maintenance

- 500 metres radius around each wind turbine, offshore transformer module and/or their substructures and foundations comprising the Beatrice Offshore Wind Farm whilst work is being performed as indicated by the presence of maintenance vessels.

- It is noted that the 500 metre safety zones will roll with the maintenance activity with no more than two maintenance vessels working at any one time. Vessels are advised that anchors associated with the maintenance vessels may extend outside of the 500 metre safety zone.

Only vessels associated with the Beatrice Offshore Wind Farm Operations and Maintenance may enter statutory Safety Zones with prior permission.

Marine Coordination centre will be responsible for monitoring and policing the Safety Zones; and can be contacted directly for advice.

Further information on the application of Safety Zones can be obtained from the Marine Coordinator. Users are advised to keep clear of maintenance activities, including Safety Zones, within the Beatrice Offshore Windfarm area in line with Marine Guidance Note 372.

ALL VESSELS ARE REQUESTED to give all maintenance vessels a wide berth.

MARINERS ARE REMINDED to navigate with caution and keep continued watch on VHF Ch. 70 / 16 when navigating the area.
